• Opening Remarks - on my side:

•

- This is a nostalgic report for me, as I look over what has been a busy year, and my last operating report as GM.
- •
- Words cannot convey how honoured and privileged I have been to lead operations at the station with an absolutely amazing staff, board, loyal group of volunteers and sales crew. They always stepped up to the plate.
- •
- Here are some highlights ...

• Facilities and equipment

- The square footage of the radio station has always made it a cozy place. We were able to increase our square footage by trading advertising to add to our rental space. This has resulted in 'the green room'. We secured the envelope with the assistance of trade from Picton Home Hardware, Peter Morkis and crew from Woodcrafters and Al Edmunds from Greenbush electric. We secured a small storage area from our landlord, which has enabled us to relocate some items to the basement, but storage will always be at a premium.

EASTLINK

- After struggling with our deteriorating Bell lines, we were able to take advantage of Eastlink's trenching down Cold Storage Road to the farm centre to switch over
 our phone service and also go to a higher speed internet. Unfortunately budget considerations did not allow us to add additional lines at this time.
- •

DIGITAL BOARD AND NEWSROOM MIXER

• We replaced our news room mixer, which needed to be serviced and repaired, due to a beverage spill. with a smaller unit which was \$350 instead of \$3500 dollars. Pat has determined the replacement part required and we should have a good repaired spare unit for the production room. It is of the utmost importance that all beverages are capped and no beverages come within several feet of a control board at any time.

- With the opportunity to live broadcast some of the Dukes away games, we used the remaining Parrott foundation grant money for equipment to trade in installed digital on air board for a higher model, which would provide remote live broadcast control of the on air studio. This is an extremely important piece of functionality to be able to expand future remote broadcasting capabilities.

TRANSMITTER

• We purchased on trade, a new air conditioner for the transmission shack, recognizing that our old unit was finishing its 4th year. This is absolutely essential to keep temperatures down in the shack. As well, Matt Dwight has installed great monitoring systems and monitors the health of not only the transmission equipment, but also of our emergency generator system.

DJB Automation System

• We had several upgrades to DJB over the year, which improved stability, providing the golden rule of letting the system return from one command at a time is obeyed, however the shortcomings of the access database it was built on present obstacles which cannot be overcome. We investigated several other systems, which did not pan out at our price point, however we received word that DJB is changing to a sequel server technology - which is the best news we could get about the product. We have asked to be an early offline beta tester. The patience of both DJs and staff has been sorely tried over the last year again with this software, but the manufacturer has continued to work on the issues which are problematic. This last one is huge for us.

Accounting system

- Conversion completed and is showing promise in making it easier to complete reporting and preform audit
- •

Radiothon

- Last year's Radiothon was our most successful effort ever, showcasing 4 days of music with county musicians, very capably organized by Megan Hutton. From 8 am to 8 pm Thursday to Sunday the county was treated to all styles of music. Our listeners were amazed at the depth and variety of music in the County. Musicians, volunteers visitors and staff had a blast.. we were really hopping. We also showcased our wonderful radio plays - which we are anxious to continue with on a broader base. All in all, we were able to able to raise enough money to pay down \$30,000 in debt plus the interest payable, leaving us with \$46,000 in of original startup equipment loan to repay. It was a fantastic effort from the community, the musicians, and our 99.3 family - of volunteers and donors.

Alternative fundraising events

- Aside from our Radiothon, small fundraising events are important to help bridge the gap between advertising revenue, Radiothon revenue and what we need for operating expenses.
- Prepared grant to finish green room and reconfigure studios work has now been split- design and plan for on air and production studios made possible by trade with Picton home hardware will allow for installation of new equipment one reconfiguration of space... that's the cutover.

MARKETING AND PARADES

- 99.3 County FM was in **all parades this yea**r, using John Hoppers beautiful vintage camaro in the Canada Day parade, with our new sound system and intrepid volunteers notable especially was the energy Mike Farrell brought to the party.

WEBSITE REBUILT

- Deb S, Treat Hull, Pat Larkin, Tristan Treasure, Pearl Hucul and Kara Hepburn all worked to get the rudiments of the new website up, which is now much easier to change. Look for continued improvements please make suggestions on what you want to see
- New events tent
- We received our beautiful new events tent as the last portion of a grants purchase which will greatly enhance our visibility in the community and also protect our remote broadcast equipment. This equipment now has battery operation too, and can be independent of power, at least for short periods of time. We also purchased a rugged laptop to operate the field soundboard when required

A Tremendous Year

- 55 quality programs 100% through Volunteer Engagement.
- \$108,000 in broadcast time provided to the not for profit community at no charge to support events. This is outside of our public affairs programming, news, and ad-lib support.
- Over 6,000 Public Service Community Event notices read annually.
- Over 6,000 guests through the station annually.
- Over 250 Community Media Releases immediately read on-air covering news of closures, emergencies, and events.

A Tremendous Year

- 83% of the organizations directly involved with Vital Signs have been on GrapeVine multiple times.
- 765 GrapeVine segments, 1600 newscasts.
- 96 volunteers, 2 full time, 3 part time.
- One of the largest community radio stations in Canada in just over 4 years.
- Extremely active year with the business and arts community. Over 500 enterprises have chosen 99.3 County FM to deliver their message to The County.

A Tremendous Year

- We exceeded our sales targets by 3%.
- We met our donations targets.
- Grants have become more elusive however we are pursuing all avenues. This year we supported operations entirely through advertising and donations.





- Studio expansion, equipment secured, preparing for the next phase in renovation and installation.




Administration




